Commissioner Madigan stated she has noticed more and more items at Council meetings for approval of invoices due to the purchasing requirements not being met. Her office will be putting together some suggestions of how to minimize the number of invoices being brought to Council for approval of payments and if possible reasons why this is happening.

# Discussion: 3rd Quarter 2019 Financial Report

Commissioner Madigan reported the following revenue as of 09/30/19:

- 83% of property taxes has been collected.
- VLT aid was received on June 26th and represents the full payment for the year. The \$2,325,592 received in 2019 was equal to the amount received in 2018.
- The amount of sales tax received as of 09/30/19 was \$7,693,006. This is an increase of 9% from 09/30/18.
- Collections of hotel occupancy tax are slightly higher than in 2018 and are expected to meet the 2019 budget.
- As of 09/30/19, \$623,055 of mortgage tax has been received.

Water and Sewer: Approximately 35% of water revenues have been recorded.

Expenses: All liability insurance has been paid in full for the year and final retirement payments will be made on 12/15/19.

Discussion and Vote: 2019 Finance Policies (19-529)

Commissioner Madigan advised the Finance Office reviews its policies annually to be sure they are in compliance. Changes were included with the agenda.
