1. **APPLICATION MUST BE FILLED OUT COMPLETELY**, including signatures of the property owner, the applicant and the sign erector. **NOTE:** Use additional form(s) if more than one sign is to be erected.
2. To-scale drawings, with dimensions must accompany application: (a) drawing of the building facade(s) of the establishment to which the sign will be attached (include the shape and accurate location of the sign), if a wall or roof sign, or if awning graphics; (b) detailed drawing of the sign face(s), including any sign support structure (height above grade, etc., and a site plan with location) if a freestanding sign; (c) detailed drawing of the sign profile, including any sign support structure.
3. The sign permit fee of **\$150.00** (check made payable to *Commissioner of Finance*), must accompany application.
4. Liability insurance coverage:
 - (a) *For sign contractors acting in the capacity of a sign contractor:* a Certificate of Insurance on an ACCORD form with Commercial General Liability Insurance of One Million Dollars (\$1,000,000) per occurrence aggregate naming the City of Saratoga Springs as an Additional Insured and Certificate Holder;
 - (b) *For business owners acting in the capacity of a sign contractor for the project:* The Business General Liability insurance may be used.
 - (c) All applicants must provide proof of NYS Statutory Workers Compensation (form C105.2) and Disability Insurance (form DB120.1) or a waiver of same as determined by the NYS Workers Compensation Board (Homeowners – form BP-1; Contractors – form CE-200).
