INSURANCE REQUIREMENTS:

The City of Saratoga Springs requires for all Street Opening Permits appropriate certification of Worker's Compensation and Disability Benefits and a Certificate of Insurance naming the City of Saratoga Springs as an **Additional Insured on a Primary and Non-contributory Basis for the following coverages:**

- **Commercial General Liability:** \$1,000,000 per occurrence and \$2,000,000 aggregate including completed operations and personal injury;
- **Pollution Liability Insurance:** \$1,000,000 per occurrence aggregate if conducting environmental remediation under federal and/or state mandate;
- **Statutory Workers Compensation and Employer's Liability Insurance** for all employees (*Please note that for this coverage per NYS Law, the City of Saratoga Springs shall not be named as an Additional Insured.*)

The Certificate naming the City of Saratoga Springs as **Additional Insured on a Primary and Non-contributory Basis AND Certificate Holder**. Certificates of Worker's Compensation and Disability Benefits and Certificates of Insurance should be addressed to the attention of:

RIGHT OF WAY PERMIT POLICY

1. Work must commence within 48 hours after Estimated Start Date and be finished within 48 hours after Estimated Completion Date. Changes to Start and Completion Dates must be pre-approved by DPW.
2. There is a MINIMUM CHARGE of \$65.00 for the application plus an additional \$290.00 (\$460.00 for Broadway) for street to be opened. The City Engineers Office will provide spot check inspections during work and may invoice you for these inspections in accordance with the Commissioner of Finance fee schedule.
3. Excavators must contact the underground locating company (DIG SAFELY – New York) at 1-800-962-7962 at least two working days PRIOR to actual street excavation. **Does not include the day of the request.** This is for the purpose of ascertaining if any other underground utilities are present in the street.
4. Excavators must notify the respective City Street Foreman on the morning of the day that work will be done. Foremen are at the Garage at 7:00 a.m. and appreciate a call at that time. Garage phone: (518) 584-3356.
5. Excavators will be responsible for replacing clean backfill material and proper compaction of all street repair work. If the excavator fails to properly compact backfill material and settling occurs after the excavated site has been patched, any further patching done by the City will result in the applicant being charged an additional fee.
6. During November through April, restoration of an emergency street opening is to be accomplished by placing clean fill and rubble, properly compacted and surface patched with acceptable cold patch material. The City will remove temporary patch and place hot mix blacktop in the spring.
7. The following should serve as a guideline in undertaking all trench and blacktop street repairs:
 - All asphalt pavement excavations are to be SAW CUT. This will allow for a more uniform edge to facilitate repair of the blacktop surface.
 - Sub-grade backfill material shall be placed by the contractor and shall meet minimum requirements for properly compacted trench backfill material.
 - Stone rubble sub-base gravel material shall be placed and compacted to a minimum depth of 12" (twelve inches) by the contractor. (rubble may be furnished by the City).
 - Top Course Hot Mix Asphalt Material (NYS DOT Type 6 or 7) shall be placed and properly compacted to a minimum thickness of 4" (four inches). (Depending on permit circumstances, this work will be done by City DPW Crews). CITY will remove old debris material and patch (blacktop) excavated area.
8. Applicants will NOT be issued NEW permits until work is completed to the City's satisfaction and all applicable tap drawings have been received.

Reminder: *when installing a new water service line, the old service line must be disconnected at the corporation.*
9. Under no circumstances will excavators be permitted to use City materials on private jobs.
10. NO PERMITS will be issued from July 1st through Labor Day or from November 15th throughout the winter months, unless there is an emergency situation and special permission is received.
11. A MINIMUM of 48 (forty-eight) hours notice will be required for tapping water mains in non-emergency situations.
12. Plumbers are required to use compression fittings. Use of compression fittings will avoid a poor flaring and are easier to work with during emergency repairs.
13. Plumbers must submit a detailed drawing on the attached form of all new services (both water and sewer) showing measurements to curb box, point of connections and point of entry into house.
14. Excavators will be required to secure any excavation left overnight using his own equipment (lanterns, barricades, signs, etc.) and will be responsible for excavation until all work is completed.
15. Applicants must notify the Fire Department, Police Department, Emergency Corps and School Bus Garage when CLOSING a street. Additionally, any application that will result in a street/lane closure must be submitted three (3) days in advance, with a written traffic protection and maintenance plan, for approval from the Saratoga Springs Police Department.
16. Insurance Certificates must be provided each year prior to any work commencing on a City Street. The certificate must name the City as an **Additional Insured on a Primary and Non-contributory Basis AND Certificate Holder**. See the insurance requirements section on the first page.
17. In the event that any tree or tree roots of a city tree are to be disturbed, you must first consult with the City Arborist.
18. Any work being performed on a water or sewer line must be done by a licensed plumber, a contractor approved by the City, or Inspected by an Engineer.
19. Applications must be submitted at least three (3) business days, before project is to commence, for approval. If this is an emergency, **please contact our DPW Garage M-F at (518) 584-3356 as soon as possible.**
20. It is the applicant's responsibility to make sure permit and traffic protection and maintenance plan is approved before work is to commence. Contractor/Excavator is solely responsible for the job site and all utilities should remain undisturbed, unless the permit authorizes work on the utilities. In the event of an emergency, including but not limited to a leaking or broken: corporation, water service, curb box, water main, water valve, fire hydrant, sewer lateral, sewer main, storm lateral, and/or storm main, the City of Saratoga Springs DPW Utilities Department shall be contacted to make the appropriate repair. The charge for the emergency repair will be based off the current City fee schedule for DPW labor and equipment.
